

## Membership Categories

Active is a member who performs fire fighting duties and has an event average of at least 20%. An event is described as any combination of fire department drills and emergency calls. Additionally, firefighters must participate in at least 33 percent of fund raising activities. Non-fire suppression members must have participated in 66% of fund raising events in order to have the privilege to vote in the elections at the December meeting.

Life is a member who has contributed 20 years of faithful service to the Fire Department. Any active member may nominate an individual for life membership at the January business meeting. A Life member must attend 6 meetings to have voting privileges at the December election.

Junior membership is reserved for members 14 years old, until voted in at the monthly meeting that immediately proceeds their 18th birthday. At this level fire ground operations are limited. No blue lights will be permitted for use in this membership classification. Junior members have no voting privileges. All members in this classification must maintain a C average in school.

Contributing or Honorary members are a member who supports the mission of the Twin Valley Fire Department in an indirect way. This membership class does not hold voting privileges.

## Membership Application Process

Complete the entire application.

Submit application and application fee to fire department member.

Your application will then be announced at the next monthly business meeting. Business meetings are held the first Wednesday of each month at 7 pm.

The membership committee will conduct a background check and discuss your eligibility for membership.

Your application will be announced at the next month meeting with the findings of the membership committee. If approved, a 90 day probation period will begin.

Applicants are encouraged to attend work nights, every Thursday at 7 pm, and introduce themselves to the officers and current department members.
